Commentary on Water Quality

All the samples collected from this zone to date have complied with the Water Supply (Water Quality) Regulations 2016. No Undertakings or Authorised Departures currently apply to this water supply zone.

Additional Water Quality Information

The supply to this area is from ground water treated at Godmersham, Chilham and Howfield Water Treatment Works. These works are owned and operated by South East Water. As part of the treatment process at Howfield Water Treatment Works phosphate is dosed for plumbosolvency control. Icosa Water take a bulk supply of water from South East Water with the connection point occurring in South East Waters East Ashford supply zone. This water is transported via Icosa Waters publicly regulated water supply network to supply the new development known locally as Conningbrook Lakes.
